- Value added and retention of origin in rural areas

SOME KEY MESSAGES

- Need to be clear on why we are into Tourism and who should benefit from Tourism
- Local communities cannot be an "after thought" or a means to an end to protect tourism investments
- Tourism cannot be successful without a sustainable food production sector and climate smart agriculture
- Agricultural biodiversity and heritage and the culture of food in the Caribbean enhance the "value proposition" of a sustainable tourism product
- Agrotourism must be integrally linked to Food & Nutrition Security and to the management of Chronic Non Communicable Diseases (CNCDs)

Why are we here: to discuss regional opportunities for increasing trade of Agri-Food products, and investment in agribusiness development, particularly in rural communities, in partnership with the tourism sector. The expected outcome of the workshop is the identification of a major regional project on agrotourism which will be submitted for funding under the 11th EDF envelope.

I look forward to a full 2 days of presentations and rich discussions, and to our joint efforts in contributing to creating a sustainable future for us all.

Everything she spoke about resonated with me as her presentation validated the fact that tourism and the agri-food sector are intricately linked and that sustainable development in our countries and across our region cannot be attained without the creation of linkages between these two sectors.

Liz Thompson is a Barbadian who has worked in development policy for nearly 25 years. She is currently Barbados' Ambassador to the United Nations. She previously served in a number of professional roles including as an elected Member of Parliament from 1994 to 2008 and as Minister of Government during this period. At various times, she held the portfolios of Energy and environment, Housing and Lands, physical Development and Planning and Health. Ms. Thompson also led Minority business in the Barbados Senate from 2008 to 2010.

Nations, with specific responsibility as one of two Executive Coordinators of the Rio+20 Conference on Sustainable Development. In this role she also developed the highly successful Higher Education Sustainability Initiative. Thereafter, she was engaged in a number of advisory roles within the UN system, including on the transition from the Millennium Development Goals to the Sustainable Development Goals in the office of the UN Secretary General, UNDP, the President of the General Assembly and on the Secretary General's global energy initiative, Sustainable Energy for All.

Liz has considerable experience in national and international policy and negotiations, including with international financial institutions and within the UN system and processes. As a Minister, she led major policy initiatives in Barbados

such as the island's national sustainable development, green economy, sustainable energy, policies and the greening of government facilities. Her professional engagements have included consultancy in the Caribbean and Internationally to private sector entities, governments and UN agencies.

Liz has lectured and spoke in many countries and at universities including Harvard, Yale, Colombia, North Carolina, AWaterloo and the West Indies on a number of issues in development, environment and energy. She has authored several papers and articles on these themes and is the co-author of two books on sustainable development published in 2014. She is certified in negotiations, alternative dispute resolution and arbitration, is an attorney at law (LLB abd LEC) and holds two Masters degrees a general MBA with distinction from the University of Liverpool and an LLM in Energy Law, with minors in the law and policy of renewable energy and environment from the Robert Gordon University.
